Interview with...

the Chairman, Laurence Goode

What does your role in the organisation involve?

As Chairman of the PSSA, I believe there are two main facets; facilitator and ambassador. The first to ensure all



councils' views are properly considered, these represent all members' interests, and to push for forward progress based on common consensus. The second to ensure the clearest message gets out, and the maximum feedback comes back, to and from the most relevant audience; specifiers, end users, governments, regulators, and new prospective members. The first task I have definitely found a lot harder than the second!

Where have you previously worked?

My whole working life has been in security, a significant part in the USA. Perhaps some of the most interesting projects were for U.S. prisons; very scary places, and with completely different issues to be solved where the aim is to keep a large number of very determined people in, and control their movements around a site, rather than defend against an external threat.

Whats your vision for PSSA over the next year/ 3 years/ 5 years?

While it has been extremely hard, I believe that tackling the hardest job first; getting the Verification Schemes up and running means we have the fundamentals right to gather some real momentum in the right direction. The focus now moves onto providing our members with some real value in terms of information and benefits, growing the membership, developing the adoption of Verification across the industry, and with this credibility starting to become a voice for where our industry goes, and how it raises standards over time. Over the next 5 years, and based on growing interest already being seen from around the world, I can now see the PSSA becoming internationally recognised as a key improvement driver and ambassador for our industry

Whats the first thing you would do if you were prime minister?

Something to give some

immediate results while I got larger issues underway; raise motorway speed limits in clear weather (balanced by reduction to pedestrian speeds near schools and high risk areas) while raising penalties for lane hogging. Also there must be some simple ways of spreading the use of all our infrastructure more evenly through the day; I'm sure that many jams and bottlenecks are caused simply since everyone wants to use roads and transport at such narrow peak times.

Bavak Security Group Launch New Speedgate B-protect BR-P1

The Belgium department of Justice have set up a complete new requirement program for Perimeter Protection in and around prisons.

Qualifications for the program consist of two elements, 1st: a burglar resistance, with lighter tools than the European RC standards, but for a longer duration with two persons, 2nd: a static pressure resistance, to withstand a situation where a crowd Bavak Speedgate

is pushing. Depending on the location and treatment level, the resistance must be 1,500, 2,500, 3,500 or 7,500kg. The requirement for a pressure resistance of 3.500kg was a complete new item for Bavak security group.

Development of the speedgate took Bavak 4 months and the manufacturing and assembling time took a further 12 weeks after approval of the final drawings. The Speedgates are driven by an 230V 1,100W electro motor, which makes the Speedgate move with a speed of 1 m/s. The Bullet Resistance qualification (BR4-6) and burglar resistance (RC3-4) were developed separately for other projects so it all came together and resulted in a Speedgate of 7.500kg.

Marshalls complete Holborn Viaduct Project

Marshalls have successfully completed a project at the famous Holborn Viaduct in Central London, supplying a number of shallow mount crash tested bollards.

The bridge, celebrating its 150th Birthday this year, was part of a major refurbishment of one of the most vital roads in the City. It all started three years ago with the renovation of the building adjacent to the bridge, which Marshalls successfully perimeter-protected with RhinoGuard™ products to prevent vehicle impact on the building's revolving doors.

As the bridge is on the boundary of the City of London and London Borough of Camden, which has a security and surveillance cordon at the Viaduct, it was decided by the City of London Police Force to add more infrastructure and road network protection around the bridge, in the event of a vehicle borne attack on the City of London.

RhinoGuard™ bollards were successfully installed on the top deck of the bridge on each side. The sleeves are manufactured from stainless steel with double red highways banding at the top, giving the product high corrosion resistanceand high visibility during low visibility weather conditions.

The bridge has now had the lighting and statures restored and the gold leaf is currently being applied, tying together the existing architecture of the surrounding space with modern, robust and safe Marshalls products.

UKTI BRAZIL TRADE MISSION



VSB's – Steady As She Goes

After a slow start, there is now a steady stream of interest in VSB verification.

Companies already within the Verification Scheme continue to submit further products for verification. There are also a number of PSSA member companies new to the Scheme that are now within the verification process.

Arrangements with CPNI are nearly complete to make their tested products list available to PSSA Members and other authorised parties. Verified products are clearly distinguished within the list, providing a sign of additional assurance to those procuring perimeter security products.

The value of PSSA Verification is also being recognised by others. The first forged certificate has been uncovered, thanks to notification to PSSA by an international construction firm operating in the Middle East which, rightly, referred the certificate to PSSA for authentication. Additional security measures are being introduced to make counterfeiting more difficult. However, PSSA Members, specifiers and buyers should be aware of the need to ensure that claims of Verification are genuine. By contrast, take up of verification for fencing products has not been as anticipated, with only Zaun submitting products for verification so far.

Discussion will now commence with other bodies representing fencing industry companies to try to stimulate demand in order to recoup some of the investment made.

Installation Scheme Rocks

module The third of the PSSA Verification Scheme is nearing launch. A special interest group, lead by Rob Simmons (Fensec Ltd), has engaged members with **PSSA** industry stakeholders to establish technical criteria for an installation specification.

Assessment protocols are now being established, paving the way for pilot assessments to be conducted later this year. There has already been an enthusiastic response to the call for companies to participate in the pilot a ssessments. PSSA Members interested in participating in PSSA verification of their installation services should contact the Scheme Manager, Stephen Munden (stephen.munden@businesskeys.co.uk).

Introduction of this phase of the Scheme is likely to be pivotal to the expansion of PSSA Verification. Stakeholders, including CPNI and security consultancies, have been citing installation as an issue within the perimeter security supply industry for some time. They have welcomed this PSSA initiative.



Gunwharf Quays is a prestigious retail and entertainment complex located on the waterfront in what was once a part of the historic Portsmouth Naval dockyard. The site is owned by Land Securities and is considered to be their flagship venue.

The centre management had recognised that the existing perimeter security measures were no longer sufficient to provide the required level of protection. It was decided to install additional measures to provide the necessary enhancements.

MFD International was engaged to survey the site to identify vulnerable points, review the existing arrangements, determine the operational procedures impacting on the site security, make recommendations, obtain approval for agreed amendments, produce designs and project manage the installation. The primary objective of any measures was to provide protection for the Centre against hostile vehicle attack.

Numerous challenges were successfully overcome including installing rising bollards through a suspended slab, avoiding extensive buried services, and ensuring the aesthetics of the measures were in keeping with the historic environment and did not present an overly fortified appearance.

The HVM measures were installed to the complete satisfaction of the centre owners, local residents, City Council and the police.
